In the classroom the children choose their free play stations when called upon and their names were placed on the wall. Educators were involved with the children, sitting at a table colouring while another assisted with pearler beads. After the second group of children arrived, the groups played and prepared for snack time.

Licensing staff observed outdoor play time and walked around the area with the Administrator discussing corrective measures that are to be made such as stabilizing the wooden structure in the corner and ensuing all screws and nails are pounded in to avoid injury.
