Comments: Extinguishers in the 3s room and the kitchen were last noted as maintained in 2020. Operator stated that fire prevention advised that they need to schedule the updates of these with another service provider; the operator has booked an appointment to have this done August 17, 2022.

Comments: One play house, outside the infant area, has a hole with jagged edges inside the house, where fingers might be caught. There is also a crack on the roof of this playhouse. These need to be repaired to remove any sharp edges or the playhouse can be removed or replaced.

Comments: The infant area currently only has turf and requires at least one more type of surfacing for play.

Comments: Bottle of Bona floor cleaner observed on a high shelf in the largest play area. Operator moved to locked cupboard before the end of the inspection.			

General Comments
<p>I arrived at the centre for renewal inspection around noon and observed the older children eating lunch. They had just returned from the wetlands and were enjoying pizza while talking with their peers and educators.</p> <p>The younger children were napping in a separate space while some of the preschoolers who did not want or need a nap played quietly in another room. The nap rooms were a comfortable temperature, and the children had some quiet music playing in the background.</p> <p>The younger children who were playing during this quiet time were enjoying the variety of activities available to them including various toys and items for dress-up. Their educator was actively involved in their play, allowing</p>

the children to "do her make-up" in their game of pretend when they asked. All educators spoke to the children on their level and in calm, level voices. They redirected the children when needed, comforted them when they appeared upset, and encouraged them to consider their peers feelings when there were small conflicts over sharing or taking turns.

After nap the children enjoyed a snack before going outside to play. Educators handled transitions smoothly, working together as educators to prepare the kids for outside play. They ensured kids had sunscreen applied, hatson, and water available to them. There were ample activites and toys observed outside for them to play with with.

I observed evidence of the children's learning in form of art projects and portfolios throughout the centre in learning stories and on the walls.
