Comments: Daily attendance records of children are being used, but facility has all children listed on the same attendance record for both licences in this building. Each classroom should have their own attendance records sheet for their children. The attendance record sheet should be with the educators at all time even when they leave the facility. Educators currently carry a written list of the children that they bring with them.			
26(2) The operator of a licensed facility shall require the parent or guardian referred to in subsection (1) to sign a declaration confirming that he or she has read and understood the content of the handbook.	26(2)	Aug 27, 2021	
Comments: 1 out of 10 audited child files did not have the consent confirming the parents have read and understood the parent handbook.			
39(2) A licensed facility shall have a separate locked storage space that is inaccessible to the children for each of the following: (a) toxic products, chemical products and cleaning supplies;	39(2)(a)	Aug 18, 2021	
Comments: Lysol wipes were found on a shelf accessible to children. These must be locked and inaccessible to children.			
40(1) An operator of a licensed facility shall ensure that personal belongings of a child receiving services at the licensed facility that are brought to the licensed facility, including combs, brushes, toothbrushes, towels, washcloths, bedding, pacifiers and soothers, are (a) labelled with the name of the child.	40(1)(a)	Aug 20, 2021	
Comments: Some of the children's water bottle were not labelled with the name of the child. Personal belongings must be labelled with the child's name.
