Comments: At the time of the renewal inspection visit, the cleaning supplies were stored upstairs in the home and inaccessible to the children however, cleaning supplies need to be stored in a cabinet, container or a closet that is secured by a lock and key. When licensing staff brought this to the attention of the operator she told licensing staff that she will secure the cleaning supplies in a cabinet, container or closet that will be secured by a lock and key.

<p>General Comments</p> <p>At arrival, licensing staff was screened for Covid-19.</p> <p>The children were washing up to have their snack when licensing staff arrived to conduct the renewal inspection. After snack the children washed up and engaged in free play until all of the children were finished eating. When all of the children were finished eating the operator took out her guitar for a "sing along." The songs that were sung were: Down By the Bay, If Your Happy and You Know It,, The Bumble Bee Song, On Top of Old Smokey and "Shake Your Sillies Out. The children were heard singing along with the words, dancing and doing the appropriate motions. A lot of laughing was heard by all children. The operator is very engaging, expressive and interactive with the children.</p> <p>While conducting the inspection the licensing staff observed some challenging behaviour that the operator was able to encourage the children to problem solve and stepped in when needed. The operator encouraged the</p>

children to be empathetic towards each other.

The children and operator went outdoors for outdoor play. The children engaged in exploration of the mud kitchen and mixing chalk and rain water in a mini sized pot and called it, "milk water." Licensing staff also heard the same child refer to the "milk water" as "white water" as well. Other children were engaging in a drawing activity while outside and another child was practicing his soccer skills by kicking a ball across the lawn.

The inside and outdoor environments were very welcoming and engaging with a variety of activities available to the children.
