## General Comments

When I arrived, the preschool children were getting ready for snack. The educators encouraged independency but also helped the children with opening items in their lunch when needed. Following lunch, the children went outside. The children have lots of toys and different materials to encourage different types of play. Some played with the mud kitchens, others searched for bugs, some did bracelets while others played with the structures and ran. The children were very happy, lots of laughter when playing outside.

Following outdoor time, the children came inside, had lunch and then did quiet time. The children that don't nap, engaged in quiet play during that time. It was noted by the educator that during the first 30 minutes, the children are only allowed books. Just a reminder that children who do not nap, should have choices of quiet activities.

When the afterschool children arrived, they put their indoor shoes on and sat in groups. The educators then asked them about their weekend. I thought this was a very nice activity to do with the children, they were all so exited to talk about their weekend. They followed by reading the children a book, snack time and free play in different stations.

I observed lots of positive child guidance such has gentle reminders and encouragements. The educators are respectful, attentive and engaged with the children.

The indoor play areas are clean and well organized. The children have an abundance of toys and learning materials to meet their interest and learning needs.

There was a playmat near the tables in the preschool room that the corners were rolled up and the mat was not sitting flush to the floor. I observed a child tripped and fall over the corner of the mat. I advised the educator that it was a tripping hazard and the mat was removed immediately.

Please make note of the following COVID-19 guidelines:

Drop-off and pick-up:

"It is encouraged for only one identified adult per family to be responsible for the drop-off and pick-up of the

child or children at the facility. Staggering these times should be considered when needed to reduce the number of people at facility at the same time. These activities should be managed outside, unless the adult absolutely needs to come into the facility. When interacting with other adults and physical distancing is not possible, community masks should be worn".

## Record keeping:

"Employees of early learning and childcare facilities are required to complete a daily log of children, staff members, visiting professionals, volunteers, and visitors who work, attend or visit the facility regardless of the duration. The log must include names, contact information, and the date and time they are in the facility. This information must be provided to Regional Public Health or government officials to assist with contact tracing should a confirmed case of COVID-19 been identified. Please review Appendix D – Daily Log for more information."

During the time I was there, a parent entered the preschool room to pick up a child. As per the above, it is recommended that parents only enter the centre if they absolutely need to. Anyone entering the centre must also be logged. In this case, the parent was not logged, and the educator went home for the day. I advised the alternate educator to ensure the parent is logged on the daily log sheet.

I recommend for renewal.
