General Comments

Upon arriving at the facility, the children were engaged in free play activities such as playing with wooden blocks. The educators were observed preparing invitations on tables for the children to engage in if they wanted to. As the rest of the children arrived at the facility with their parents, the educators were observed greeting the children and taking daily attendance. Later, an educator was observed playing with the dinosaur sensory bin while other children played with the prepared invitations. A visual timer was set to indicate transition times. Once it was time to transition an educator prompted the children to start cleaning up and gather on a carpet to have circle time.

Circle time included signing songs, going over the days of the week and the weather. After, an educator introduced an indigenous book to read with the children. The educator was heard asking questions to the children while reading the book. After, the children wash their hands for snack time. The children were supervised at all times while eating their snacks. The children returned to free play activities such as playing in the ball pit and with train tracks and wooden blocks.

Later in the morning, the educators prepared all of the children's outdoor clothes and encouraged them to get dressed. When the children asked for help the educators kindly agreed. Once one small group of children were ready, an educator completed a head count before going outside to play. The playground had a variety of play materials such as shovels, bowls, snowball makers and sport balls to play with. One group decided to make a snow man while another group played a tag "monster" game with an educator. The educators were observed playing with the children while supervising them. When conflicts for materials happened, the educators encouraged the children to share and put timers on to make sure that all the children had a turn with the toys of their choice. Once it was time for lunch, the educators asked the children to line up to return inside. Once inside, the children used the washroom and washed their hands before sitting down for lunch. After lunch, the children sat down and read books before some children laid down for a nap.

The indoor environment was clean and well organized. The children's personal belongings were properly stored and labelled. The parent information board was verified and found to be complete. Pictures of the children and their families were observed along with recent winter and dinosaur arts and crafts. A large dinosaur web was

observed on a bulletin board with quotes, questions and art made by the children. Evidence of planned activities was observed as recent fossils and dinosaurs' crafts were present. The sensory bin included dinosaurs, bones, eggs and a volcano. Six child profiles were verified and found to be complete. Staff files were also verified and complete.
