Comments: As set out in the Early Childhood Services Act and Licensing Regulations, an operator must have copy of a completed Criminal Record Check/Vulnerable Sector check (CRC/VS) that is clear of any offences as listed in Schedule B for any associated persons over the age of 18 living in the ELC Home. During the inspection on July 8, 2019 the operator failed to provide the Inspector with a copy of these checks for an associated person. As such, the associated person is not be in the ELC Home during operational hours when children are present until a new CRC/VS check is re-issued demonstrating that there are no offences as listed in Schedule B and is provided to the Inspector.
