General Comments

Upon Licensing staff arrival, there was one child in attendance and the Operator was engaged in drawing at the art table with a child.

The entry way was organized. Children's belongings were tidy on hooks with their names and in cubbies with baskets. Children's artwork was on display throughout the space and elements of nature were incorporated with learning stories. Play material such as dress up costumes, tea party accessories, construction trucks and tools, loose play pieces, books, and art supplies were in good condition and easily accessible. Family homes were printed on wooden blocks and there were positive words of affirmation as well as print outs on personal feelings posted on the walls. There was evidence of purposeful planning as a weekly activity plan was posted on the main door with photos of the children engaged in the week priors' activities.

Before going outdoors to play, a gentle reminder was heard by the Operator for the child to use the bathroom and wash their hands. The outdoor space offers ample natural shade from trees throughout pathways and surrounding the play structure. There were learning stories on display throughout the outdoor space, flower and vegetable gardens, wooden stepping stumps and bridges, as well as an outdoor art station and sensory wall. When returning indoors, outdoor shoes were changed, and hands were washed.

Once indoors, the Operator was observed sitting with the child working on a large butterfly puzzle. The Operator offered kind words of encouragement and the opportunity to problem solve with separating the puzzle pieces into piles of border pieces and similar shapes and colours. While working on the puzzle, a second child arrived prior to lunch time. Proper handwashing was observed upon arrival and personal belongings were hung up.

During inspection, files were verified, and all documentation was in order. There was evidence of positive and caring relationships between the Operator and children as the environment was calm and caring environment. Monthly fire drills and outdoor maintenance checks are being conducted and logged, and daily attendance forms are being completed.
