<p>General Comments</p> <p>Licensing Staff arrived at the facility to perform a Monitoring Inspection. Upon arrival the class was playing outside in the fenced in playground. The children were observed making mud pies and other "treats" for the Educator. Children used bowls, shovels and dirt to prepare their creations. The playground is clean and offers a variety of play materials such as balls, frisbees, shovels, buckets, mud kitchen materials, bug catchers and magnifying glasses. The Educator asked the children if they would like to continue playing outside or go indoors. The children chose to stay outside for a few extra minutes.</p> <p>Once inside the children hung their jackets up on their hooks, removed their outdoor shoes and once indoor shoes were on, they lined up to go into the classroom. Hands were washed as the children entered the class. The children gathered for a quick Bible Story and song. The children were seen laughing and smiling as they danced and sang along with the song. The Educator had prepared a few activities for the children this morning. A new Dinosaur puzzle was displayed at one table, and a painting activity was set up at another table. Two large sensory bins with corn starch and water were available for the children to use. The children freely explored activities throughout the classroom before washing their hands for morning snack. The Educator sat at the table and ate snack with the group. The children enjoyed sharing knock knock jokes as they ate.</p> <p>The classroom is bright and welcoming. Family pictures, children's artwork and learning stories are displayed on the walls of the classroom and hallways. Pre-planned activities were noted; the Educator prepares a daily schedule with a flexible time frame. It is evident the children are familiar with the daily routine and Educators. Transition periods were smooth. Only positive child guidance was observed during today's Monitoring Inspection. The Educators were seen getting down to the level of the children when communicating. Praise and words of affirmation were heard.</p>
