<p><b>General Comments</b></p> <p>Licensing Staff arrived at the facility to conduct a Monitoring Inspection. Upon arrival, the children had yet to be dismissed from school. The morning preschool classroom was bright and welcoming. The Educator stated that the children have been working hard at decorating their classroom for Saint Patrick's Day. Several shamrock banners were displayed in the classroom. In the play kitchen area, Saint Patrick themed napkins were neatly piled on top of a small table.</p> <p>Once the children were dismissed from school, they were greeted by the Educators outside. The children were promptly signed into attendance before lining up their bookbags and jackets against the school. One Educator was observed bringing basketballs, yoga mats and chalk outside for the children to use. Today the weather is calling for sunshine and warm temperatures, so the Educators were planning on spending most of the afternoon outside.</p> <p>Some children were observed playing basketball while a group of children sang and cheered for their peers. Others used their imagination and turned the yoga mats into kites, flying them around the playground, pretending the puddles were rivers with crocodiles in them. The Educators were well spread out on the playground and were observed checking in with all of the groups of children throughout the afternoon.</p> <p>Only positive child guidance was observed today. The Educators engaged in activities with the children, asking the children about their games and helping trace one another with chalk. Staff and child profiles were reviewed on site today. The files were organized and contained all required documents. An incident log was also reviewed. Attendance records were up to date, and a first aid kit was brought outside.</p>
