Comments: Educators intentionally placed a variety of materials on the table to invite and encourage children to explore upon arrival. These materials included bracelet-making supplies, art materials such as paint, markers, and paper, as well as LEGO, building blocks, dolls, and clothing for the dollhouse. The selection of materials was purposeful, supporting creativity, fine motor development, and imaginative play. Deficiency is now compliant.

General Comments
<p>During the monitoring inspection conducted on October 17, 2025, children were observed actively engaging in a variety of activities throughout the learning environment. One child was playing independently with the dollhouse and maneuvering a small bike around the space using figurines. Another child was seated in the reading corner, flipping through the pages of a book. A small group of children were involved in a necklace-making activity, using beads and string that had been purposefully planned and set out prior to their arrival.</p> <p>Children demonstrated initiative and curiosity by interacting with educators. For example, one child asked, "Can you help me with the bracelet?" Educators responded promptly and supportively, engaging with children at their level and facilitating learning through conversation and guidance. Throughout the inspection, educators were consistently present and attentive, observed sitting with children during activities, asking open-ended questions to extend learning, and encouraging peer interactions and collaboration.</p> <p>The physical environment had been thoughtfully rearranged to create more defined and purposeful learning areas. Photos of the children were displayed throughout the space, contributing to a sense of identity, belonging, and personalization within the environment.</p> <p>The parent board was reviewed and found to be comprehensive and up to date. It included recent inspection reports, inspector contact information, the daily routine schedule, and documentation of fire drills. The board was easily accessible and served as a clear communication tool for families.</p>
