Comments: During the follow-up inspection, the inspector observed that a signed statement from the children's parent confirming they have read and understood the parent handbook is present in the 6 child files audited. Deficiency is now compliant.			
27 An operator of a licensed facility shall obtain the written consent of a parent or guardian of a child receiving services at the licensed facility before doing any of the following: (b) permitting, in the case of illness or soiled clothing, the child to shower or bathe or showering or bathing the child.	27(b)	Nov 20, 2023	Jan 12, 2024
Comments: During the follow-up inspection, the inspector observed that consent for bathing or showering in the event of illness or soiled clothing is present in the 6 child files audited. Deficiency is now compliant.			
27 An operator of a licensed facility shall obtain the written consent of a parent or guardian of a child receiving services at the licensed facility before doing any of the following: (c) permitting the administration of medication in the circumstances set out in section 46.	27(c)	Nov 20, 2023	Jan 12, 2024
Comments: During the follow-up inspection, the inspector observed that consent for administering medication is present in the 6 child files audited. Deficiency is now compliant.

Comments: During the follow-up inspection, the inspector observed that consent for outings and excursions is present in the 6 child files audited. Deficiency is now compliant.

Comments: During the follow-up inspection, the inspector observed that consent for permitting photographs and videos of child for publication or social media is present in the 6 child files audited. Deficiency is now compliant.			
27 An operator of a licensed facility shall obtain the written consent of a parent or guardian of a child receiving services at the licensed facility before doing any of the following: (k) posting photographs of the child at the licensed facility to illustrate the child's learning.	27(k)	Nov 20, 2023	Jan 12, 2024
Comments: During the follow-up inspection, the inspector observed that consent for posting photographs of child in the centre to illustrate learning is present in the 6 child files audited. Deficiency is now compliant.			
30(3) An operator shall maintain the indoor play area of a licensed facility to ensure the safety of the children.	30(3)	Nov 20, 2023	Jan 12, 2024
Comments: During the follow-up inspection, the inspector observed that the wall in the 4-year-old room has been painted. Deficiency is now compliant.			
36(6) A cot, a nap mat or the mattress of a crib or portable playpen shall be washable and non-absorbent or covered with a non-absorbent layer.	36(6)	Dec 01, 2023	
Comments: During the follow-up inspection, the inspector observed that some nap mats have been repaired with duct tape while others still have tears. Duct tape or similar material is not permitted to repair a mat. As requested on November 21 and December 19, 2023, the operator must ensure that nap mats are washable and covered with a non-absorbent layer.			
39(2) A licensed facility shall have a separate locked storage space that is inaccessible to the children for each of the following: (a) toxic products, chemical products and cleaning supplies;	39(2)(a)	Jan 12, 2024	Jan 12, 2024
Comments: During the follow-up inspection, the inspector observed a can of shaving cream on a shelf in a storage area where the nap mats are stored. During the inspection, an educator placed the can of shaving cream in a locked storage. Deficiency is now compliant.			
47(1) An operator of a licensed facility shall refuse admission to a child if satisfactory proof of the immunizations required by the Public Health Act or the regulations under that Act is not provided.	47(1)	Nov 20, 2023	Jan 12, 2024
Comments: During the follow-up inspection, the inspector observed that a copy of the children's immunization record or a copy of the exemption is present in the 6 child files audited. Deficiency is now compliant.
