Comments: While gathering ratio in classrooms during the follow-up inspection the Quality Assurance Monitor noticed that the child to staff ratio in one of the classrooms was not respected. The Quality Assurance Monitor asked the educator in the classroom if there was another educator in the classroom with her. The educator in the room informed the Quality Assurance Monitor that the other staff member was only starting her shift at 9a.m. The Quality Assurance Monitor immediately went to get the administrator, and asked if someone was available to be in the classroom with the educator whose ratio is not being respected. The administrator switched 2 children into another classroom until the other educator arrived for their shift. Deficiency is now compliant. The Quality Assurance Monitor also reminded the administrator that it is their responsibility to ensure that there is enough staff in the morning to ensure that staff to child ratio is respected all the time.
