Comments: During the renewal inspection, inspector observe an educator leave the classroom on 3 occasions. 1 educator was left alone with 15 children. Child to staff ratio needs to be always maintained in a mixed aged group. Educator returns to the classroom. Deficiency is now compliant

Comments: During the renewal inspection, inspector verifies the professional learning hours for all eligible educators. 1 of the eligible educators has 5.5 hours missing to complete the 10-hr requirement. Discussions with the operator and administrator on the importance to have all professional learning hours completed during the renewal period for the designation.

Comments: Inspector observes that the previous inspection reports are not posted in a visible and prominent area. Administrator prints and places them on the information board immediately. Deficiency is now compliant.

Comments: 1 of 15 children's file verified has no contact information indicated in the medical practitioner section. Operator must ensure parents complete the child profile with the name, telephone number and name of the child's medical practitioner. Administrator contacts the parents immediately and completes the information required. Deficiency is now compliant

<p>Comments: Inspector verifies all employee files. 1 introduction to ECE certification is missing from 1 of the staff files. Administrator retrieves the certification and places a copy in the file. In the same employee file, copies of the PL hours certifications are also missing. Administrator prints the copies and places them in the employee file immediately. Deficiency is now compliant.</p>

<p>Comments: During the renewal inspection, the inspector observes an educator enter a classroom with a hot beverage that is not in a spill proof container. The educator exits the classroom immediately bringing the hot beverage away from the children. Deficiency is now compliant.</p>

Inspector is onsite March 5th and again March 6th to complete the renewal inspection. During the re-visit, inspector observes the children playing freely indoors, outdoors, snack time, lunch time and the rest period. The school aged children are present for the full day because of March break.
