Comments: During the inspection, a child did not want to participate in a Christmas coloring activity. The inspector observed an educator demand that the child color and told the child: "You need to do this, it's for your parents". The operator must ensure that the day is flexible, allowing children to initiate their own learning, explore at their own pace and follow their individual interests.			
24(1) For the purposes of subsection 20(1) of the Act, the following records and documents shall be maintained on the premises of a licensed facility: (b) child records that include: (iv) the name, address and telephone number of at least two individuals authorized by the child's parent or guardian to pick up the child and to be contacted in case of an emergency if the parent or guardian cannot be reached,	24(1)(b)(iv)	Nov 29, 2023	Dec 18, 2023
Comments: During the follow-up inspection, the inspector observed that the name, address and telephone number of at least 2 emergency contacts are present in the 4 child files audited. Deficiency is now compliant.

Comments: The inspector observed that the missing copy of a valid first aid (FA) certificate and a valid cardiopulmonary resuscitation (CPR) certificate has been placed in the staff member's file. Deficiency is now compliant.

The operator must ensure that the child's file includes the signed statement from parent confirming they have read and understood the parent handbook.</p>			
27 An operator of a licensed facility shall obtain the written consent of a parent or guardian of a child receiving services at the licensed facility before doing any of the following: (c) permitting the administration of medication in the circumstances set out in section 46.	27(c )	Dec 20, 2023	
<p>Comments: During the follow-up inspection, the inspector observed that consent for administering acetaminophen is missing in 1 of the 4 child files verified. The operator must ensure that consent for administering acetaminophen is provided by the parents.</p>			
27 An operator of a licensed facility shall obtain the written consent of a parent or guardian of a child receiving services at the licensed facility before doing any of the following: (g) transporting or providing for the transportation of the child.	27(g)	Nov 29, 2023	Dec 18, 2023
<p>Comments: During the follow-up inspection, the inspector observed that consent for transporting the child or providing transportation is present in the 4 child files audited. Deficiency is now compliant.</p>			
27 An operator of a licensed facility shall obtain the written consent of a parent or guardian of a child receiving services at the licensed facility before doing any of the following: (j) permitting photographs and videos to be taken of the child for publication or social media.	27(j)	Nov 29, 2023	Dec 18, 2023
<p>Comments: During the follow-up inspection, the inspector observed that consent for permitting photographs and videos of the child for publication or social media is present in the 4 child files audited. Deficiency is now compliant</p>			
27 An operator of a licensed facility shall obtain the written consent of a parent or guardian of a child receiving services at the licensed facility before doing any of the following: (k) posting photographs of the child at the licensed facility to illustrate the child's learning.	27(k)	Nov 29, 2023	Dec 18, 2023
<p>Comments: During the follow-up inspection, the inspector observed that consent for posting photographs of the child in the centre to illustrate their learning is present in the 4 child files audited. Deficiency is now compliant</p>			
30(3) An operator shall maintain the indoor play area of a licensed facility to ensure the safety of the children.	30(3)	Nov 28, 2023	Dec 18, 2023
<p>Comments: During the follow-up inspection, the inspector observed that the broken treadmill, elliptical, stationary bike and foosball table have been removed from the facility. Deficiency is now compliant.</p>			
32(1) An operator of a licensed facility shall provide indoor play area materials and equipment that are (d) clean and in good repair.	32(1)(d)	Dec 01, 2023	Dec 18, 2023
<p>Comments: The inspector observed that a wall plate has been added to the electrical outlet in the gym. Deficiency is now compliant.</p>			
48(2) An operator of a licensed facility may supply food to a child receiving services at the licensed facility that a parent or guardian of the child brings from the child's home if the food is labelled with the child's name and refrigerated, as required.	48(2)	Nov 29, 2023	
<p>Comments: During the follow-up inspection, the inspector observed that 2 out of 4 lunchboxes verified are not labelled with the name of the child. As requested on November 28, 2023, the operator must ensure that food brought from home is labeled with the child's name.</p>			
50(2) The operator of a licensed facility shall inform the parent or guardian of a child involved in an incident on the day the incident takes place and shall ensure that the parent or guardian signs the daily log to confirm their awareness.	50(2)	Nov 28, 2023	
<p>Comments: During the follow-up inspection, the inspector observed that the date and time of an incident was not documented on the incident log. During the inspection, the educator wrote down the date and time of the incident on the incident log. The inspector also observed that the care provided to a child was not indicated on another incident log. The operator must ensure that the incident logs show the child's name, date, time, injury that occurred and care that was provided, what happened and the parent's signature.</p>
