<p>General Comments</p> <p>The Operator performed a very thorough Covid-19 screening by asking licensing staff the updated screening questions as well as signing the licensing staff into the facility.</p> <p>At the time of the renewal inspection it was observed that there weren't any documented pieces of children's learning posted in the play environment. Licensing staff relayed the importance of posting such documentation in order for the children to revisit the learning experience that accompanies purposely planned curriculum</p>

activities. It was also noted that a daily schedule of purposely planned activities was not posted. Licensing staff also relayed the importance of posting a schedule of purposely planned curriculum activities as per the Early Childhood Services Act. The Operator suggested to post the daily activities on the parent/communication board and then file this away for future inspections.

As far as documentation is concerned, it is also a requirement to post documentation such as the renewal inspection report along with the monitoring inspection report as per the Early Childhood Services Act. Please ensure that all reports are posted in a clearly visible and prominent place in the facility associated with the licence.

During the renewal inspection it was noted that a piece of trim was removed from the stairwell which left three tiny nails exposed which is a safety hazard in the indoor play space. When this was brought to the Operator's attention, the Operator assured licensing staff that the hazard will be removed the same day of the renewal inspection.

While licensing staff was inspecting the outdoor environment it was noted that the gate leading to the fenced in area where the above ground pool is located was not locked and secure. This gate is required to be locked in order to avoid any safety hazard that may occur.
