Comments: During the follow-up inspection, the inspector observed that each child has 3.25m ² of space. The educator was observed ensuring that room capacities are respected. Deficiency is now compliant.

Comments: During the follow-up inspection, the inspector observed that the damaged chairs have been removed from the facility. Deficiency is now compliant.
