Comments: During the renewal inspection, the inspector observed that 1 of the 2 emergency contacts listed in 1 of the 10 child's files audited is located more than 1 hour away from the facility. The operator must ensure that the name, address and telephone number of at least two people authorized by the child's parent to pick up the child and contact in case of emergency if the parents cannot be reached is noted in all children's files.			
36(4) The rest area of a full-time early learning and childcare centre and an early learning and childcare home shall allow for a space of at least 46 cm between each crib, portable playpen, cot or nap mat.	36(4)	Feb 21, 2024	Feb 21, 2024
Comments: During the renewal inspection, the inspector observed that 2 separate sleeping cots in two of the four classrooms are not separated by a space of 46 cm. During the inspection, a staff member moved the cots to allow more than 46 cm between the sleeping cots.			
39(2) A licensed facility shall have a separate locked storage space that is inaccessible to the children for each of the following: (a) toxic products, chemical products and cleaning supplies;	39(2)(a)	Feb 21, 2024	Feb 21, 2024
Comments: During the renewal inspection, the inspector observed two cans of shaving cream in a storage cabinet in one of the four classrooms. During the inspection, the administrator placed the two cans in a locked storage area. Deficiency is now compliant.			
46(1) An operator of a licensed facility shall only administer medication to a child receiving services at the licensed facility in the following cases: (d) if the medication is prescribed, the medication is labelled with the name of the physician, the instructions for use and the time period for use.	46(1)(d)	Feb 23, 2024	
Comments: During the renewal inspection, the inspector observed that 2 inhalers are not labelled with the name of the physician, the instructions for use and the time period for use. The operator must ensure that prescribed medication is labelled with the doctor's name, instructions for use and the time period for use.			
48(4) If an infant is receiving services at a licensed facility, the operator shall (d) ensure that each bottle is stored with a cover in the refrigerator.	48(4)(d)	Feb 21, 2024	
Comments: During the renewal inspection, the inspector observed that two infant bottles are stored inside the infant's lunchboxes with an ice pack. The operator must ensure that infant bottles are refrigerated.			

General Comments

During the renewal inspection, the inspector observed indoor free play, lunch and quiet time. The inspector also observed an educator reading books to the children.

During the inspection, the outdoor temperature is -24 degrees with the windchill. The children played in the gym during the time they would normally play outside.
