<p><b>General Comments</b></p> <p>Completed renewal inspection today. Educators were observed to be engaged with the children within all of the rooms. Nurturing and respectful relationships were visible throughout the facility. Invitations were set up for the children throughout the rooms. There was evidence of the implementation of the NB Curriculum Framework displayed throughout the center. The environments were set up with a variety of activities and centers to explore based on the interests of the children. Toys and activities throughout the rooms were clean and well organized. Children were also observed to be actively engaged within sensory opportunities and engaged with books. The children circulated the interest centers freely while actively exploring the materials and props that were available to them on low open shelving.
