General Comments

Upon arrival at the facility, the children were lined up at the gym door. The children waited until the educator completed a head count of all of the children before bringing them to the washroom to wash their hands before having hot lunch. All the children washed their hands, grabbed their lunch boxes and sat at the lunch tables. Some children had hot lunch while others ate their lunches from home. The educators were attentive to the children while they ate lunch. After lunch, the children put their lunch boxes away and washed their hands before engaging in free play activities.

During free play activities, the children played with building blocks, magnetic blocks, dramatic play kitchen and others read books. The indoor environment was clean and well organized. There was various play materials located at an accessible height for the children to reach. The parent information board included all of the necessary information. Child and staff files were verified and found to be complete. The emergency procedure plan was visibly posted at both exits and on the parent information board.

When it was time to transition, the educators were heard saying "1,2,3, eyes on me" and the children were heard saying "1,2 eyes on you". As the educator had the attention of the children, she asked the children to start cleaning up their activities and get ready for the field trip to Wilmont Park. The children agreed and started cleaning up their activities. The children were observed gathering their water bottles and outdoor shoes before lining up at the door. The educators were observed encouraging the children to line up while they gathered a first aid bag, bug spray and the daily attendance sheet.

Once everyone was ready, the educators were observed completing a head count before leaving the gym and again as the children were entering the bus. Once arrived at the park, the educators were observed completing a head count and proceeded to a large field. In the field, invitations to play were available for the children. The children engaged in activities such as playing with the parachute, playing with bubbles and playing on the playground. During this time, the educators were observed encouraging the children to stay close to the group and to safely play around the trees. The educators were in touch with the children's needs by offering the children some water. The educators were observed kneeling to speak to the children and encouraging the children to respect one another while playing.
