### General Comments

A renewal occurred today.

The children were observed during inside morning play, morning snack, going and coming back from a walk/outside play, lunch and nap/quiet time.

Discussed with Executive Director that upon arrival for inspection the educators in room 9 were cleaning from the day before, vacuuming the rugs. All children were present during this time. Discussed that whoever closes at the end of the day, ensures that the room is cleaned and ready for the next day before the children and educators arrive.

Discussed when medical forms are completed that the educators return these to the office to be filed in the children's files and not left in their learning environments.

The children and educators in the four rooms were welcoming to the inspector during the inspection. The

children were eager to show what learning they were engaged in. From creating with playdough and the "glue station". The children's current interests are displayed in each of the rooms in the forms of webs, learning stories and art.

Handwashing was observed occurring several times during the inspection.

Positive interactions were observed occurring between the educators and the children in their care during the inspection.
