<p>General Comments</p> <p>Monitoring inspection completed today. Children and educators were observed in the indoor play environment and transitioning to outdoor play.</p> <p>Indoor environments are purposefully planned with a variety of materials accessible to the children. Educators set up invitations to play that are in keeping with children's interests and favorite activities.</p> <p>Documentation in many rooms with webs, photos, children's art and learning stories. Ensure all documentation</p>

General Comments

is dated to demonstrate that it is current.

As discussed with administrator during inspection, one room observed to require support to ensure materials are inviting and plentiful for the children. As well, evidence of children's belonging in the room can be supported with photos, artwork, etc.

Mark making documentation in one room highlighted the many ways children make marks in the indoor and outdoor environments using different mediums, tools and materials. This documentation demonstrated how opportunities to engage with mark making and print are available throughout the day and how children build their skills around print.

QA Monitor discussed with an educator the importance of recognizing when children are becoming bored with an activity and it is time to move on. When children are no longer showing interest in an activity, rather than taking time away to deal with the beginning of challenging behaviors, it is in everyone's best interest to move to a new activity or provide other choices for children who may no longer want to participate.

Transitions from indoors to outdoors were observed to move smoothly.

Ensure mandatory attendance records are completed correctly, with one child per line and include children's first and last names.

Fire drill record and incident logs were observed and complete.
