## **General Comments**

Comments:

A Monitoring Inspection was completed this morning. Children were observed during inside play, preparing for, and eating snack, and transitioning to outside play.

Room 7 - Children were observed sitting on the rug and taking part in their morning meeting. Children were observed singing songs, sharing stories, and talking about planets. Educators stated that the children enjoy their morning meetings. Children were also observed cleaning up, washing their hands, and preparing for snack. Room 8 - Several well-defined learning / play areas were observed. Children were observed washing their

hands before snack. A conversation was had with educators regarding markers, glue, and scissors and how these items can be better accessible to the children. One of the ideas that was discussed was to keep these items in plastic containers, with lids, and to store these containers within the children's arts and crafts center. These items are to be available and accessible to the children.

Room 9 - Children were observed washing their hands before snack. Children were observed sitting at their tables, eating snack. Several forms of documentation were observed in this room - "What we know about taste", photos, learning stories, and children's artwork. Several well-defined learning and play areas were observed, some of which included: building, books, dramatic play, mark marking, and arts and crafts. The play kitchen included several recycled food boxes / containers, and laminated pictures of foods, food accessories, and photos of grocery stores.

Room 10 - QAM observed the room, while the children played outside. Two tabletop activities were set up and ready for the children – building cubes and cube pictures, and magnetic tiles. The dramatic play area had limited materials – dress up clothing in a bin, 2 babies, and a firefighter hat. More materials to be added to the dramatic play area. Children were also observed during outside play. Children were observed playing with trucks and cars, filling them with rocks and snow, and dumping them.
