General Comments

Name of operator

A Monitoring Inspection occurred on June 5, 2025.

Children were observed engaged in both indoor and outdoor free play. Educators noted that the children are currently very interested in the bee and caterpillar life cycle, growing herbs and vegetables indoors, exploring a tuff tray filled with bird seed and sand, and being active outdoors through walks, the splash pad, and new outdoor sports activities. Educators have included themselves and their interests in their own documentation, and they are actively participating in children's activities outdoors, helping to extend the learning environment beyond the classroom.

The facility maintains a daily incident log, and parents of children present at the center are granted entry at any time. Outdoor play occurs for at least one hour during each four-hour block of time when the majority of children receiving services are in attendance, weather permitting. Monthly emergency evacuations are completed and posted. A clearly visible and prominent place is available to post the license, current inspection report, current monitoring reports, and any orders for compliance. The daily routine is posted in each room, and evacuation procedures are also posted and easily visible. Educators have incorporated ideas from the web and learning stories into various areas of the classroom, such as the art area, library, kitchen, and dramatic play areas.

The changing area is located within one meter of a sink, and diaper changing procedures are posted and visible to staff completing diaper changes. Drinking water is available throughout the day, and allergy information for any child is posted. Webs have been completed with the children and have been expanded upon with educators.

General Comments

A conversation was held with the Administrator regarding the strengths and needs of the facility. Strengths identified include educators' efforts to extend curriculum outdoors and bring the natural world into the classroom, as well as the presence of various forms of literacy in the indoor environment. However, some needs were also discussed: the library bookshelves should be fully stocked and reflect the children's interests, and the condition of the books should be maintained. Additionally, one bathroom garbage can used for diapering was observed without a lid; please ensure that all garbage cans used for diapering have secure lids to maintain hygiene standards.
