General Comments

After lunch, it was clean up and then nap time. For the children who didn't nap, they played quietly with toys while watching a show on the television. It is recommended to limit television time for the children. Please see section 7.3 of the Operator Manual for information on use of digital technologies. The children then went outside to play again after their quiet time.

I noticed the use of webbing on the wall, which indicate planning of programming, and it showed the topic of hibernation. I asked the children about it, and they were excited to tell me about bears hibernating, and then proceeded to show me a bear cave they made with their hibernating teddy bears inside.
