General Comments
<p>When I arrived the children were coming in from outside and were eating. Various age groups played outside this morning and did some water play before the weather got too hot. As discussed, please remember that small pools are not allowed to be used for children to be in, but water tables and other forms of water play are permitted. After lunch, some children had a nap while others played quietly.</p> <p>I looked at staff and child files during my visit. I looked at approximately a third of the child files and they are well organized and contain all necessary information. It is evident that they are updated regularly. The staff files are also well organized and most contain all necessary information. There are some files that need updated first aid and staff signed statements.</p> <p>I observed positive child guidance techniques such as redirection and encouragement and I saw educators actively engaged with the children. I saw positive interactions with educators and children during my visit.</p> <p>The playground appears well maintained and has sufficient shade and materials for the children. As discussed,</p>
