Comments: While inspecting the school-aged outdoor play space for hazards, licensing staff noted that the wooden playhouse, that had protruding nails and staples, is still unsafe as the protruding nails and staples have not been removed. Please remove the wooden house from the school-aged outdoor play space or remove the protruding nails and staples in order to maintain the safety of the children playing in this space.			
31(4) An operator shall ensure that the outdoor play area of a licensed facility (b) consists of more than one surface to permit different types of play.	31(4)(b)	Oct 26, 2022	
Comments: While licensing staff was inspecting the preschool play space, it was noted that this play space remains to have only one type of play surface. Please ensure that at least one more play surface to permit different types of play.			

General Comments
<p>Licensing staff arrived at the licensed facility to conduct a monitoring inspection on October 26th, 2022.</p> <p>When licensing staff arrived at the licensed facility, the children were finishing up their lunch and getting ready to have quiet/nap time.</p> <p>On the day of the inspection, it was noted that the school-aged indoor play space had more space for the school-aged children to engage in play than the last monitoring inspection.</p> <p>On the day of the monitoring inspection, it was noted that there were enough educators on site to maintain child-to-staff ratio and no need to put the inclusion support worker into the child-to-staff ratio in the afternoon when the school aged children arrive off the school bus.</p> <p>The transition from lunch time to quiet time was a smooth transition. The educators put on some lullaby music on for the children during this time.</p>
