| General Comments  |
| <p>When I arrived, the children were not here yet but the staff were getting the classroom ready, cleaning and disinfecting.</p> <p>Because I arrived at the centre before the children arrived, I was able to observe the school bus drop off. Four staff went out near the road, they all had their first aid kits and the attendance sheets. I also overheard the staff confirm the number of children before going outside. The bus passes in front of the centre and goes down the road before it turns around and drops off the children at the centre. When the bus went by on the other side of the road, the staff showed excitement and waved at the children in the school bus and some children were seen waving back. When the bus finally arrived at the centre, one staff stayed at the door of the bus to count the children while the others directed the children towards the centre.</p> <p>Some children went directly outside, and others came inside for a snack. The children were playing outside on the structures and they were also given some bottles of bubbles to play with.</p> <p>The centre is clean and well organized, including the outdoors. Everything is well maintained.</p> <p>The educators were engaged with the children. Positive conversations were observed between the educators and the children such as talking about their day at school.</p> <p>Positive child guidance was observed such as encouragements and gentle reminders when needed.</p> |
