Upon my arrival I was greeted and screened by Lynne.

The children were outside and having snack inside the tent. Following snack Lynne and the children gave me a tour of their outdoor space. The outdoor space is like a magical enchanted forest with different interest sections throughout. The outdoor space is designed in a way to encourage pretend and imaginary play. The children were playing in the mud kitchen washing the dinosaurs and were playing hide and seek with rocks. There is also a paved area where the children can ride bikes and play basketball.

The children then went inside around 11 for indoor play, lunch and quiet time. The children know the routine and transition very well from one activity to another. After handwashing they showed me around their play area which is equipped with many different learning opportunities such has dolls, costumes for dress up, a natural area with loose parts and wood blocks and many other interest toys/learning activities. The children then showed me their arts and crafts room where they have an abundance of arts and crafts supplies at their disposal. The children followed with lunch and a rest period. In the afternoon, the children did different activities and then went outside.

The programing is purposely planned and meaningful based on the interest of the children. Lots of evidence of learning activities. Currently the children have a vast interest in bugs and insects and Lynne has provided them with many different learning opportunities around those interests.

Lynne is very engaged with the children and I observed lots of positive child guidance such has encouragements and acknowledgement of achievements. The children seem to have a good relationship with Lynne and appear to be happy in their Early Learning and Childcare Home.

The Department of Education and Early Childhood is now asking that all medication and toxic products be locked by key. Therefore, I have asked Lynne to move those items to an area where they can be locked by key.
