Comments: While verifying the outdoor play area, the Quality Assurance Monitor noticed that a pallet in the infant outdoor play area had broken pieces. The Quality Assurance Monitor mentioned to the educators that the pallet was broken, and it was a risk for children to get their foot stuck in it or get hurt. The educator stated that the pallet was going to be removed and that the children would not be let on the pallet anymore. The Quality Assurance Monitor advised the administrator of the concerns regarding the broken piece on the pallet. The administrator advised that the broken pallet would be removed and replaced as soon as the operator was on site. The administrator sent a picture of the broken pallet being replaced to the Quality Assurance Monitor via email. Deficiency is now compliant.

General Comments

The Quality Assurance Monitor was able to observe children playing outdoor, where educators were engaged in different types of play with children. The Quality Assurance Monitor observed one educator playing hide and seek with children, helping the seeker count and look for children hiding in the playground.

The Quality Assurance Monitor was able to observe an educator playing on the pretend car and singing the wheels on the bus with children. The Quality Assurance Monitor also observed an educator on the lookout for bugs and worms with a group of children.

The Quality Assurance Monitor noticed that the educators were very attentive to the children and positive interactions between educators and children were observed.

The Quality Assurance Monitor also noticed that while children are waiting to use the washroom or for diaper changes, the educators sign with the children to keep them occupied.
