<p><b>General Comments</b></p> <p>Inspection completed on this date for annual renewal of license. Children were observed by licensing staff arriving to the program. Handwashing was completed upon children's arrival and children were given an opportunity for their choice in activity and for eating a snack from their packed lunch. All children in attendance were signed in and educators knew the number of children in attendance when asked throughout the inspection as children were arriving and being picked up.</p> <p>All children were observed to be engaged in an activity. Room was well organized and clean with sufficient materials for the number of children present. Materials included in the room were developmentally appropriate and based on the interests of the children. Pumpkin long-term project was observed, and children enjoyed explaining it to licensing staff. A large reading area was a nice addition to the room and gave a lot of opportunity for children to independently choose a book based on their interests.</p> <p>Educator was observed taking a child's temperature when they said they were not feeling well. When child did not have a temperature, the educator reassured them and made suggestions on what they could do quietly until their parent arrived.</p> <p>All required records and documentation were in place. The administrator was able to present all medicare information on the emergency contact list. Some medicare numbers that have been obtained after initial enrollment need to be added to children's file so it can be reviewed by licensing staff, a few children files were missing this piece of information and need to be updated.</p> <p>Purposely planned sports-based programming was observed, children had planned with the educators the activities that they wanted to do in the gym area. Children had chosen mini sticks, dodgeball and soccer and staff were engaged in these activities with children at all times throughout the inspection. All children had chosen to participate in one of the activities making the gym time well-structured and safe.</p> <p>Educators were always engaged with children and positive behaviour guidance was observed at all times. Centre can be recommended for licensing.</p>
