When an educator assistant provides services to children, they do not count in the staff child ratio. After discussion with the operator this has been remedied during licensing staff visit.							
General Comments							

Monitoring inspection performed.

Upon arrival children were eating snack, then everyone had a bathroom break and to wash hands. Children returned to the classroom and sat on a mat to participate in a show and tell activity. This week children were learning about the letter K and children had to bring an item from home that began with that letter. Lots of interesting items were brought in and the educator asked questions about each item and children responded accordingly. Some items were very special to children though one child brought in a Keyboard, and all the children loved listening to the different sounds. Children were also observed in sand sensory play activity, the kitchen centre and with clean up. The educator turned on a Clean-up song and all children started following the educator's direction and helped put their play materials back on shelves etc.

The educator then commenced with story time. Children were very engaged, listening to every word and shouting out to turn the page during the story of "The Monster at the end of this Book". Great book to teach the concepts of 'turning', and 'at the end' The educator also read the "Zoom" story - great story to teach children about inclusiveness. Children listened intently as they were very quiet while the educator read the book. licensing staff observed programming posted and educators identified how the activity related to the goals of the curriculum framework. Nicely done.

General Comments

Positive child guidance was observed - Licensing staff observed staff using positive language ' looks pretty good', good job and also observed comforting a child when outside. As per discussed with the Operator support staff must not be left alone with children as they are not counted into the staff child ratio. This was remedied during my visit and on days when a child cannot go outside, will join another group.

Children were observed getting dressed for outdoor play. The climbing structures are phenomenal. Children enjoyed sliding today. Parents were observed picking up their child at the end of the morning in the outdoor play area.

One observation - stationary equipment will need to be moved in the spring so that it is separated by 72 inches on all sides when it is next to another stationary piece of equipment as per CSA.

School age children arrived during licensing staff visit and were getting ready for outdoor play.
