Comments:	Comments: Puddles of liquid observed on washroom floor near the toilet in one of the stalls. Educator within room reports that it was cleaner from when washroom was cleaned and that the paper towel does not work to absorb the liquid while cleaning. This can not remain on the tile floor as it is a slipping hazard and a safety concern. Discussed with administrator.

Comments: Space within the room for gross motor activities is depleted. Materials and equipment to be added. This space may need to be relocated or rearranged to support gross motor opportunities within the room. Dramatic play area is becoming depleted. There were no sheets on children's cots today for nap time within this room. Educators report that they do not have cot sheets for this room.

Comments: Equipment within the dramatic play area is in poor repair. There are knobs missing from kitchen sink and stove.							
General Comments							
The children within the 2/3s room were observed running around during transition time from lunch to rest period during today's inspection. Behavioral concerns such as throwing toys, hitting, and refusal to leave a cot that was							

during today's inspection. Behavioral concerns such as throwing toys, hitting, and refusal to leave a cot that was not their own were noted during this time. These behavioral concerns made it difficult for some children to rest uninterrupted. Discussed strategies that could be used going forward with some of the educators (ex: redirecting children who refuse to nap to a quiet activity based on the child's interest). These concerns were discussed with the administrator and additional support is recommended within this room at this time of day, as it proves to be challenging.

Bedding was not ready for rest period today. Bedding had been washed in the morning and was not yet dry, which resulted in extended wait times (30-45 minutes) for the children. Educators should be purposefully planning for transition times and ensuring that all materials are readily available when needed. Extended wait

times can lead to behavioral concerns and educators should be setting up the environment to support smooth transitions on a daily basis.
