## Two/Threes Room:

Transition times in this group appear to be a challenging time for both, children and educators. Transition times must be purposefully planned to help alleviate behaviour challenges. Example - invitations set up, involving the children in the clean up of lunch and set up of cots, story time, etc.

Broken and worn materials have now been removed from environments, however these materials have not been replaced. Example: Dramatic play food, puzzles and play kitchen. Ensure materials that are frequently used and become worn are replaced.
