Comments: In 9 child records reviewed, the name, address, and telephone number of two emergency contacts were provided. Deficiency is now compliant			
30(3) An operator shall maintain the indoor play area of a licensed facility to ensure the safety of the children.	30(3)	Feb 13, 2025	
Comments: During the monitoring inspection, the Quality Assurance Monitor observed rodent droppings in the indoor play area, including on toy shelves, in the washrooms, and in storage spaces. This observation was immediately brought to the administrator's attention, and the Quality Assurance Monitor inquired if they were aware of the issue. The administrator acknowledged their awareness and explained that an extermination company had placed traps, although no rodents had been caught yet. The Quality Assurance Monitor advised the administrator that public health would be contacted and instructed them to await further guidance from public health before proceeding with cleaning the droppings.

Comments: During the monitoring inspection, the Quality Assurance Monitor observed several water bottles that were not labeled with the children's names. The Quality Assurance Monitor reminded the administrator that all personal belongings must be labeled with the child's name.

<p>Comments: During the monitoring inspection, the Quality Assurance Monitor observed a pile of children's personal belongings scattered throughout the cubby area. The Quality Assurance Monitor reminded the administrator that both the administrator and educators must ensure that each cubby is used exclusively for the assigned child.</p>

<p>Comments: During the monitoring inspection, the Quality Assurance Monitor observed a pile of personal belongings, including jackets, snow pants, school bags, and lunch bags, scattered across the floor in the cubby area. The Quality Assurance Monitor reminded the administrator that children's personal belongings must be stored separately.</p>			

**General Comments**

The Quality Assurance Monitor is on site to conduct a monitoring inspection. Throughout the visit, the child-to-staff ratio was maintained as required.

During the inspection, the Quality Assurance Monitor observed children eating their snack and engaging in indoor play.

A discussion took place between the administrator and the Quality Assurance Monitor regarding the functioning of the group. The Quality Assurance Monitor observed that although the children are divided into three groups to ensure no more than two educators are assigned to each group, children were allowed to move freely throughout the facility. The Quality Assurance Monitor noted that the room appeared chaotic, with children climbing and jumping off tables, climbing on the back of the couch, and throwing toys. One child was observed throwing a moonball—quite hard and bouncy—against a wall while children were running around, creating a risk of getting hit in the head or face.

While risky play is encouraged, the observed behaviors were not aligned with the concept of risky play and instead posed a danger to the children. Additionally, the Quality Assurance Monitor noted several instances of inadequate supervision. On one occasion, two educators were engaged in a discussion in one corner of the room, while the third educator was positioned at the far end of the room, leaving a portion of the space unsupervised. During this time, children were climbing on the edge of the couch and jumping off. The educator intervened after a few minutes and redirected the children.

The Quality Assurance Monitor recommended that the group be divided into three separate rooms, with each group assigned to a specific room. This would reduce the chaos in the main area and allow for more effective supervision. The administrator responded by noting that this issue had already been raised during a staff meeting earlier that morning.
