The children were immediately engaged in play activities such as: collecting sticks, leaves and other natural materials to build a birds nest. Other children played in the forts that they have built in the corner of the all natural playground. What a lovely engaging outdoor play environment!</p> <p>The educators were very engaging with the children!</p> <p>While the children were waiting for the bus near the road, licensing staff observed an educator gather the children and directed them to sit on the grass to ensure their safety as the bus stop is located very close to the busy road. Please ensure that all children are gathered and sat down to ensure the safety of all children while waiting for others to be dropped off by the bus.</p> <p>During lunch time, one educator was caring for more than 15 children in the lunch room while the another educator was still in the building but in the doorway with other children however, this is not within regulation according to the Early Childhood Services Act. When this was brought to the attention of the educators, another educator immediately joined the group in the lunch area.</p> |
