Comments: It was observed that the emergency evacuation plan for May was incomplete. Educators must conduct monthly evacuation plan.			
33(2) Stationary equipment in the outdoor play area shall be surrounded by a protective surfacing and installed according to the manufacturer's instructions.	33(2)	Jun 02, 2025	
Comments: While observing the outside play area, it was observed that the mulch surfacing under the swings, was worn down. The surfacing under the swings was minimal, due to the number of children swinging during the school day. A conversation took place with educators regarding surfacing. Before the afterschool children are able to resume using the swings, educators are to ensure that there is enough surfacing. Educators to move some of the access surfacing, under the swings.			

General Comments
<p>A Monitoring Inspection occurred June 2, 2025.</p> <p>Children were observed participating in both indoor and outdoor free play. Two groups of children and educators were outdoors, with bubbles and chalk accessible for use.</p> <p>Two groups of children transitioned outdoors while one group remained inside. QAM reminded educators that all children should have the opportunity daily for outdoor play.</p> <p>Classroom 1- Children were observed in a variety of open-ended activities such as drawing, clay in the tuff tray, bracelet making, and building with Lego. The educators indicated that art and bracelet making are the current interests in the classroom. Licensing observed some children playing a board game that the children created themselves.</p> <p>Classroom 2- Children were observed building with Lego, building with blocks and making dinosaur pictures with stickers at the table. The educators expressed that these are the current interests.</p> <p>The following documents were observed, incident logs, daily attendance and 1 new staff file. The license, inspection and monitoring reports, and compliance orders are posted.</p>

General Comments

Children's art pieces were displayed throughout both classrooms.

A discussion between licensing and Administrator occurred about the following:

Classroom 1- Paint was not set out for the children. Educators are to ensure paint is available and accessible to the children.

Classroom 2- It was observed paint and glue were stored out of children's reach. Educators are to ensure that glue and paint is always accessible.
