## **General Comments**

A Monitoring Inspection occurred in the afternoon on December 10, 2025

Group One: The children were observed engaging in activities in both indoor and outdoor environments. Indoors, they were observed building with Lego, completing puzzles, playing with dolls in the dollhouse, and creating open-ended art at the table. After transitioning outdoors, the children were observed making snowmen, rolling down the hill, and jumping in the snow.

Group 2: The children were observed creating with iron beads, engaging in dramatic play in the play center, and working on open-ended art activities at the table.

Group 3: The children were observed engaging in a variety of activities, including coloring at the table, creating with clay, building with cardboard boxes, and playing with miniature dollhouses and pet figures.

Educators demonstrated positive interactions by using encouraging language and gentle reminders. They asked open-ended questions, listened actively, and extended children's ideas through conversations.

A clearly visible and prominent area was designated for posting the facility license, current monitoring reports, and any orders for compliance. Additional documents observed included incident logs, daily attendance records, and monthly emergency evacuation and fire drill documentation.
