| <p>General Comments</p> <p>Licensing staff arrived while one of the preschool children were being picked up. On the day of the licensing inspection visit, two preschool children were present at the licensed early learning and care home.</p> <p>The indoor and outdoor learning environments are lovely! Both the indoor and outdoor environment were very warm and inviting. There was a large variety of activities indoors as well as outdoors. When licensing staff arrived at the licensed early learning and care home the operator and the preschool child gave her a tour of the outdoor play environment.</p> <p>When inside licensing staff reviewed all required files, it was noted that all files were very organized as well as complete.</p> <p>While conducting the licensing inspection, licensing staff noted that there was a lot of protective surfacing located near the swing set/slide however, the protective surfacing was dispersed around swing set/slide. Please rake up the protective surfacing and then measure the protective surfacing. After raking the surfacing, measure the depth and if the depth does not meeting what is recommended by the manufactures' manual or the Canada Consumer Product Safety Act , please replenish to meet the recommended depth.</p> |
