A follow up to the renewal inspection was conducted today and all outstanding orders for compliance were completed. The facility is recommended for license renewal pending receiving the recommendation from Public Health.

Upon arrival to the facility the learning environment was set up a wide variety of age appropriate interest centers for the children to interact and engage with.

Discussed with on site administrator the summer program and ensuring that if two groups are used (one upstairs and one downstairs) that two separate government attendance records are kept.

The children were observed engaged in a variety of activities in the school-age program such as art, dramatic play, hanging with their peers and puzzles.
