Children were engaged in a variety of activities this morning (playing Jenga, reading stories, gross motor activities within the gym, cutting and snipping materials within the sensory bin, exploring costumes/dress up clothes, creative art, etc.). The children are provided with opportunities to explore their individual interests. Current topics of interest (ex: Lego, costumes and building/constructing) were identified within the environment through materials and documentation. Recommended that the children's creative art pieces, learning stories and photographs be posted at their level within the environment for the purpose of revisiting later. Hand washing routines were observed during the inspection. It was evident that the children understand and follow a daily routine.

During today's inspection, the educators interacted with the children at their level, promoted opportunities for communication and literacy, mark making, play and playfulness and supported the children's emotional health and positive identities.
