Comments: Improvements were noted with purposeful planning but additional improvements are still required. Some of the children's creative art work has been posted, program planning sheets are completed, and some accessories have been added to the environment. Staff report that some recent projects that the children have created (ex: using cardboard boxes/paint) have been well used/damaged so are no longer in the room. Having photos of these finished projects available for review would be one way to demonstrate past programming. Quality assurance monitor will follow up with staff and administrator on program planning and implementation.

Follow up inspection was completed today.

Some improvements were noted with respect to creative art areas within both rooms upstairs. Materials have been added to ensure variety and choice and shelf is positioned in a way for the children to access as they wish. Ensure creative art materials continue to be replenished daily.

A transition time toy bucket was noted on the shelf within the hallways today. Ensure these materials reflect the children's current interests and are rotated regularly. Staff report that transitions between inside/outside the classroom are going better.

Documentation should be posted in a way that children can revisit if they wish. Documentation that is currently posted is up to date, but much of this is posted high on the walls where the children can not see/access it. Posting documentation at the children's level will support curiosity, questions, conversation and expand the children's learning.
