General Comments Licensing staff arrived in the morning to conduct a monitoring visit. The children were just sitting down for snack which the operator provides. Today's snack was watermelon, toast, peanut butter and milk. Then everyone went outside to the back yard. The back yard has a swing set with pea gravel cushioning underneath, two slides, grass in the main area and a variety of play invitations such as the playhouse, mud kitchen, ride on toys, small picnic table, sand table and a storage shed with a variety of toys. The operator brought out paper, paint sticks and crayons for the children to colour. One child made a treasure map and hid treasure for the other children to find. The children used their imaginations to think of things to do and make at the mud kitchen and made a game of pouring pea gravel down the slide. The children spent a lot of time on the ride on cars and chasing around different kinds and sizes of balls. Everyone came in for lunch, all the children know the routine and the transition was smoothly. Lunches are brought from home and afterwards everyone had a nap or quiet time. The children and parents are having a graduation party at the end of the day at 4:30 with cake. All the children have a photo album of pictures of their year in their childcare to take home. The downstairs play area is clean and organized and there is an abundance of toys and materials in the downstairs play area such as a tent with cushions and books, larger lego, wooden blocks and a variety of loose parts such as dinosaurs etc. They have a visual schedule that shows the daily routine, learning stories like the one about show and tell, and children's artwork on the walls. Diapering procedures are followed and the parent board is complete. The operator will update the changes in Quality Assurance Monitor and Inspector/Investigator on the parent board.
