Comments: During the renewal inspection, the inspector observed that 1 of the 20 staff member's file is missing a copy of a valid first aid (FA) certificate and a valid cardiopulmonary resuscitation (CPR) certificate (administrator and educators only). The educator recently completed the course; however, they have not yet received their certificate. Once received, the operator must place a copy of the certificate in the staff member's file.

Comments: During the follow-up inspection, the inspector observed that the hole in the wall had been repaired; however, the wall has still not been painted. The owner must repaint the wall so that the wall is easy to clean.
