**General Comments**

A renewal inspection was completed this morning. Two children were present during the inspection. It was a rainy morning, and children were washing their hands and preparing for snack, at my arrival. Children sat at their table, eating snack, while their educator read them a Berenstain Bears story, about food. Educator was engaged with the children, asking questions, and responding to the children's questions and comments. After

snack, children were observed playing with their new pet bunny. Two Veterinarians arrived around 11am, and the bunny had a checkup. The children watched and they were very excited to see the Veterinarians weigh the bunny and listen to the bunny's heartbeat. Well defined learning centres were observed throughout the ELC Home. An Arts and Crafts Centre, a Science Centre, a Building Centre, a Dramatic Play Centre, and a Cozy Reading Corner, were all observed. Centres were well stocked with materials and accessories. Several forms of documentation were observed throughout the home - pictures of the children taking part in Messy Play, a Bunny Web, Children's Artwork, and a Culture and Diversity Poster, displaying pictures of the children's favorite places, favorite foods, their parents' workplaces, and so much more! Later in the morning, children got ready for outdoor play, and they were very excited to show me around their outside play area. Several outdoor play materials and activities were available for the children. Children were observed exploring in the woods.
