General Comments
<p>A Monitoring Inspection occurred July 2, 2025.</p> <p>Parents and children are greeted with enthusiasm upon arrival.</p> <p>The children were observed in the indoor and outdoor environments, as well as transitioning from snack time to the outdoors. The operator and children sang songs during all transitions.</p> <p>The changing area is located a meter or less from a sink. Diaper changing procedures are posted and visible. Diaper changing procedures were observed and followed.</p> <p>While inside the children were observed engaged in the music centre, dancing to music that the operator was playing on the guitar. The children were also observed playing with Play-Doh, baby dolls and looking at books.</p> <p>While outside, the children were observed painting rocks, dumping and pouring water into various buckets, and washing a Cozy Coupe car with water and paint brushes. The outside play yard was set up with various materials such as: an outside library, stumps, loose parts, paint, water, chalk etc. The children have planted a variety of flowers, herbs and vegetables outside which include peas, tomatoes, chives, peppers, oregano and sunflowers.</p> <p>Several pieces of documentation were observed throughout the room and hallway that include children art, child print and photos.</p> <p>The following documents were observed, incident logs, daily information sheets and daily attendance. The license, inspection and monitoring reports, and compliance orders are posted.</p>

A conversation took place with the Operator on the following:

Ensuring that no standing water is in the play yard buckets, tires or trays.

Ensuring that daily attendance records and first aid kit accompany the group outside of the premises.
