Operator to ensure that the Daily Attendance Record is completed each time a child arrives and leaves, remains accurate, and reflects all children present at any given time. General Comments
A Monitoring Inspection occurred in the morning on February 3, 2026.
Parents and children were observed being greeted upon arrival. Parents of children attending can enter at any time.
The children were observed engaged in a variety of activities that included playing with dolls, pushing toy trucks, and playing in the house area. The operator stated that the children are currently interested in dress-up materials, dolls, and role play activities such as playing family and teacher.
The changing area was observed to be located one meter or less from a sink. Diaper changing procedures were posted. Traffic areas were observed to be clean and free of debris.
Documentation was observed throughout the room and hallway that included learning stories, learning webs, photographs, and children's artwork.
A clearly visible and prominent area was designated for posting the facility license, current monitoring reports, and any orders for compliance. Additional documents observed included incident logs, daily attendance records, and monthly emergency evacuation and fire drills.

General Comments

A discussion occurred with the Operator regarding the following:

- Bingo dabbers were stored on a low shelf and were accessible to children. Bingo dabbers must always be inaccessible to children. They may still be used under direct supervision.
- A magic eraser was observed on the bathroom sink accessible to children. Toxic products, chemical products, and cleaning supplies must be stored in a separate locked storage space that is inaccessible to the children.
- Operator to ensure that the storage room door containing household paint containers is always locked when children are present.
