Comments: Operator is in the process of renovations in the 4-Year-old classroom. Licensing Staff spoke with Operator about submitting the necessary forms for the change.								

General Comments

Licensing Staff arrived to perform a Monitoring Inspection and introduce the facilities new Quality Assurance Monitor. Upon arrival the infants and toddlers were in the process of waking up from their afternoon nap. The oldest class, which consists of 4- and 5-year-olds were outside. Outside, the children were seen playing in the large sandbox, the mud kitchen and the wooden house. The outdoor playground has slides, tricycles, outdoor chalkboard, plasma cars and several child-size picnic tables.

All the classrooms were clean, organized and bright. It is evident that the Educators take pride in their classrooms and documentation. Family trees, webbing, learning stories, process art and photos of the children learning were seen in each class. The classrooms offer wooden materials, games, books and building material that are age appropriate. Allergies were posted in each classroom and any Medical Alerts.

In the 2's classrooms, as the children were waking up, an Educator was seen reading to a small group of children as they waited for diaper changes and hand washing. The washroom has 2 small toilets and a small sink at the child's level. Proper diaper changing procedures, and hand washing were observed. An educator was seen sanitizing each cot before putting them away. In the 3's classroom as the children woke up, they sat a table with puzzles. Once everyone was awake, sunscreen was applied, and the children went outside for afternoon snack. Hats and water bottles were brought outside.

The Senior Infants were observed having snack together, laughing and engaging with one another. Once they transitioned outside to a shaded area, they were seen coloring, laughing and playing with an Educator. Throughout the visit Educators were seen offering praise, giving gentle reminders and were attentive to the needs of the children. Educators sat with the children during snack with the children and were seen playing with them. Attendance records were up to date and the Menu is posted for families to see.
