General Comments
<p>Licensing Staff arrived at the facility to conduct a Monitoring Inspection. Upon arrival, all classes upstairs were napping. Downstairs, in the 4/5-year-old classrooms, they were engaged in a variety of activities. In one classroom, a table was set up with craft and art materials such as markers, paper, scissors, glue and pencils. The Educator was observed sitting with a group of children as they worked together to create a building using magnetic tiles.</p> <p>Shortly after arrival, the classes upstairs woke up from nap time. The children were eager to help the Educators put cots away and prepare for afternoon snack time. Due to low numbers, the smaller 2-year-old class combined with the larger 2-year-old classroom. Hands were washed before the children sat together to eat. As the children finished eating, bookbags were packed and the children began getting ready for outside. One Educator was observed changing diapers while the other Educator assisted the children with snowsuits, hats and mittens. A headcount was observed before the groups left the facility to go to the outdoor play area.</p> <p>Only positive child guidance was observed during today's Monitoring Inspection. Educators were observed speaking to the children at their level, using a gentle tone. The classrooms were bright, organized and welcoming. Evidence of preplanning was observed in each class. Each room was decorated for Valentine's Day, with age-appropriate artwork displayed throughout. Current learning stories, webbing and family pictures were observed inside the classrooms and in the hallways. An air freshener spray bottle was observed on top of a shelf in the washroom. A conversation was had on site with the Administrator as a reminder that toxic products must be locked at all times.</p>
