Comments: The inspector observed that the name and phone number of the inspector was not posted in the facility.			

<p>General Comments</p> <p>Covid-19 recovery phase recommendations:</p> <p>Inspector observed that the cleaning of the facility was recorded; however, the cleaning of the toys was not recorded daily as per the Covid-19 recovery phase recommendation. The educator indicated that the toys are cleaned after every use and that it will be added to the cleaning records.</p> <p>The inspector was not screened before entering the facility. The inspector directed the operator to ask the Covid-19 screening questions and to take his temperature. The screener is required to record the following when an individual enters the facility: name, phone number, date/time of arrival and departure. The operator stated that she will create a Covid-19 screening form.</p> <p>The above mentioned Covid-19 recommendations are required to be implemented by July 28, 2020.</p> <p>The inspector observed positive interaction between the operator and the children and that the facility is equipped with numerous learning materials and equipment for the children.</p>
